## Buyer Invoice

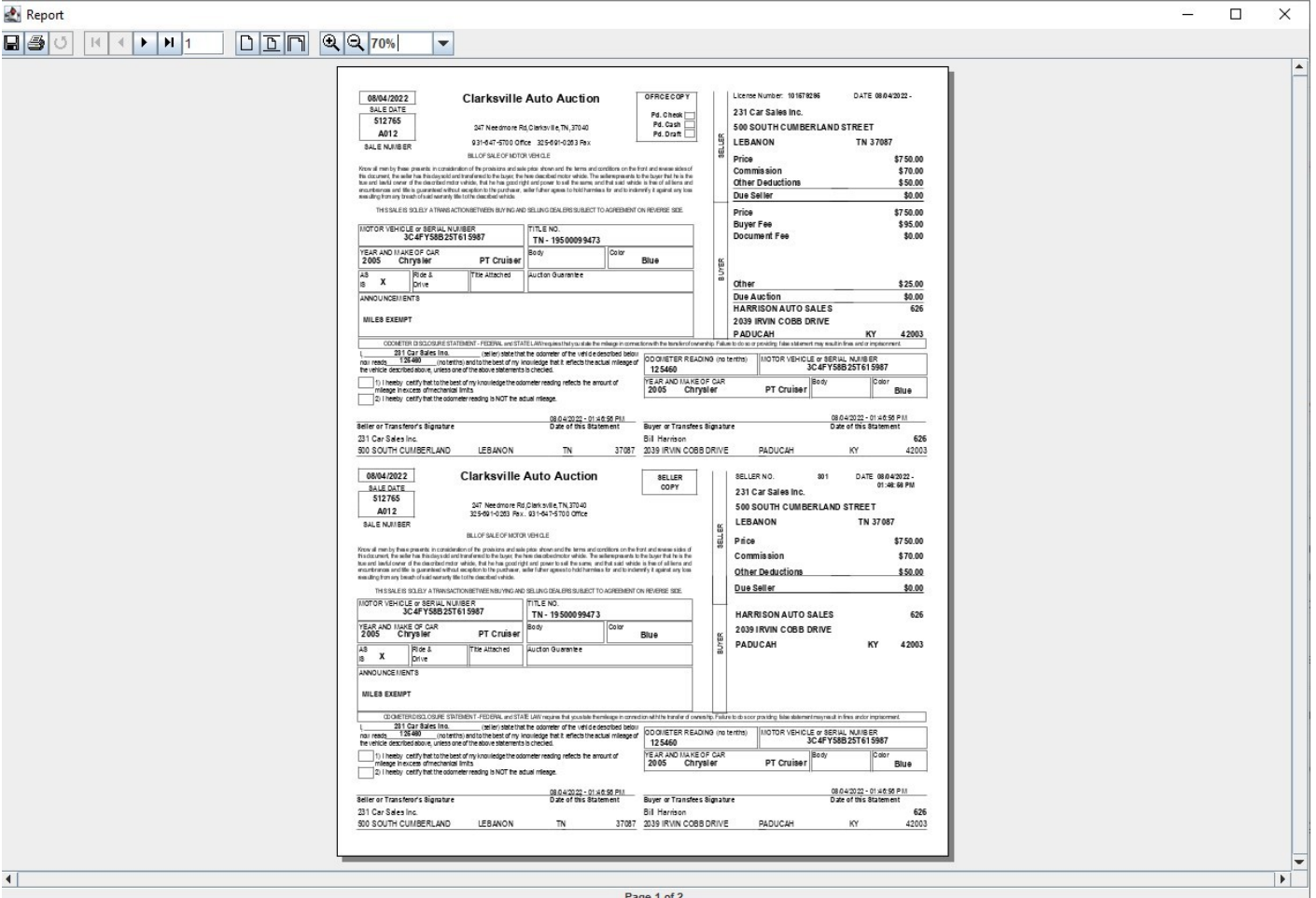

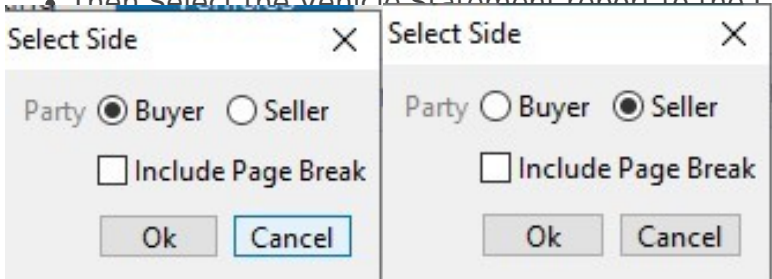
